# **Membership Subscriptions**

To confirm that at the AGM membership subscription rates were increased in line with inflation to Full - £45, Associate - £10, Couple - £75, Concessions - £25 full

The Theatre Manager has indicated that the current system of members paying subs at any repeat time during the year, usually on the anniversary of joining, is causing problems of admin, reminders, emails lost etc. So the Committee have agreed that a new system will be instigated whereby all membership falls due on 1<sup>st</sup> July of each year. There will be an interim year 2015 when members will pay a manual pro-rata calculation. The full system will be complete then by 2016.

**Example** – if your current membership falls due on 31<sup>st</sup> October 2015 – you will pay again on July 1<sup>st</sup> 2015 instead but will have 4 months deducted to reflect what you paid this year.

**Example** – if your current membership is due in January 2015 you will pay then but pro rata to take you to 1<sup>st</sup> July 2015 i.e.7 months.
